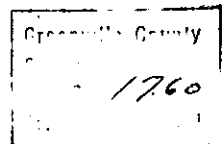

All that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, on the southeastern side of Chipley Lane, being known and designated as Lot No. 71, as shown on a Plat of Chestnut Hills, recorded in the R. M. C. Office for Greenville County, in Plat Book "GG", at Page 35, and having, according to said Plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southeastern side of Chipley Lane, at the joint front corner of Lots 71 and 72, and running thence with the common line of said Lots S. 74-36 E. 156.8 feet to an iron pin; thence running S. 14-52 W. 70 feet to an iron pin at the joint rear corner of Lots 70 and 71; thence with the common line of said Lots N. 74-36 W. 151 feet to an iron pin on the southeastern side of Chipley Lane; thence with the line of said Chipley Lane N. 9-59 E. 70 feet to the point of beginning.
