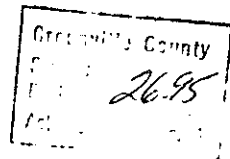
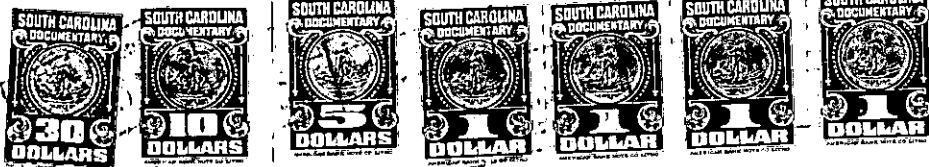
KNOW ALL MEN BY THESE PRESENTS, that We, Bruce H. Phillips and Doretta Phillips,

in consideration of Twenty-Four Thousand and Three Hundred and Fifty and 00/100 ----- Dollars, (\$24,350.00) the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Joseph E. Furman, Jr., and Melinda Q. Furman, their heirs and assigns forever,

ALL that piece, parcel or lot of land located in Chick Springs Township, County of Greenville, State of South Carolina, situate, lying and being on the western side of Coventry Lane, and being known and designated as Lot No. 64 on a plat entitled Property of Central Development Corporation, dated October, 1951, and recorded in the R.M.C. Office for Greenville County in Plat Book "BB", pages 22 and 23, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the western side of Coventry Lane, joint front corner of Lots Nos. 64 and 65, according to said plat, and running thence along Coventry Lane N. 3-15 E. 75 feet to a point, joint front corner of Lots Nos. 63 and 64; thence running along the line of said Lots Nos. 63 and 64 N. 86-45 W. 183.75 feet to a point; thence running S. 1-35 E. 75.27 feet to a point; thence running S. 86-45 E. 177.5 feet to the point of beginning.
