KNOW ALL MEN BY THESE PRESENTS, that I, Luther C. Green

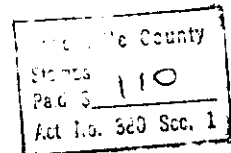
in consideration of One Thousand (\$1,000.00) Dollars,

All that piece, parcel or tract of land in the county of Greenville, state of South Carolina, containing one acre more or less, as shown on plat made by Campbell & Clarkson Surveyors, Inc. August 29, 1972, and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at a pin in the center of Bessie Road, joint corner with tract conveyed this day to Wade H. Turner and running thence with the joint line of said tracts N. 76-24 E. 255.3 feet to an old ip; thence S. 28-59 E. 117 feet to an old ip; thence S. 9-30 W. 230 feet to a pin in the center of Bessie Road; thence with the center of said road N. 39-57 W. 177.2 feet to a point; thence continuing N. 48-57 W. 203 feet to the beginning corner.
