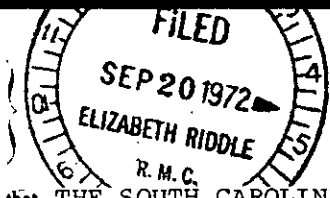

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto CARSON LAWS & ALLIE LAWS, Their Heirs and Assigns, Forever:

ALL that piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Tract No. 3, containing 5 acres, more or less, according to a plat of the property of S. C. Beattie Estate made by C. F. Webb, June 6, 1968, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on Long Shoals Road at the joint front corner of Tracts Nos. 2 and 3 and running thence along said tracts S. 5-50 E. 419.5 feet to an iron pin; running thence S. 84-15 W. 520 feet to the joint rear corner of Tracts Nos. 3 and 4; running thence along the joint line of said tracts N. 5-50 W. 419.5 feet to an iron pin on Long Shoals Road; running thence along Long Shoals Road N. 84-15 E. 520 feet to the point of beginning.
