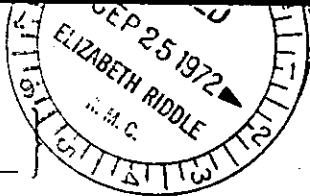

KNOW ALL MEN BY THESE PRESENTS, That STANLY D. BROWN

grantor(s) of said County and State, in consideration of the sum of one dollar (\$1.00) to me (us) in hand paid by DUKE POWER COMPANY, the receipt whereof is hereby acknowledged, do hereby grant unto said DUKE POWER COMPANY, its successors and assigns, the right, privilege and easement to go in and upon that certain tract or lot of land situated in said County and State, bounded by lands of: GREENVILLE COUNTY TAX MAP NUMBER (B1,1,1.1) ; BOUNDED ON EAST BY SALUDA DAM ROAD ; BOUNDED ON SOUTH BY OLD SALUDA BRIM ROAD ; BOUNDED ON NORTH BY (B2.1,1,30) OWNED BY STANLY D. BROWN ; BOUNDED ON WEST (B2.3,3,2) OWNED BY STANLY D. BROWN.

and to construct, maintain and operate in, upon and through said premises, in a proper manner, with poles, wires, guys, conduits, cables, transformers, and other necessary apparatus and appliances, overhead or underground lines for transmitting and distributing power by electricity, and for telephone purposes, together with the right at all times to enter said premises for the purpose of inspecting said lines and making necessary repairs and alterations thereon and additions thereto together with the right at all times to cut away or by other means to keep clear of said lines all trees, brush and other obstructions that may, in any way, endanger the proper maintenance and operation of the same; also including the right to relocate said lines over said premises to conform to any future highway or street relocation, widening or improvement.

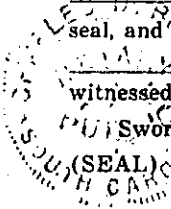
