All that piece, parcel, or lot of land in Greenville Township, Greenville County, State of South Carolina, near the northern corporate limits of the City of Greenville, near to and north of Old Camp Road, on northern side of Scott Street, being shown and designated as Lot No. 3 on a plat of the property of Walter T. Alewine, made by H. S. Brockman, Surveyor, July 22, 1946, recorded in Plat Book B at Page 190 in the R.M.C. Office for Greenville County, and, according to said plat, having the following metes and bounds, to-wit:

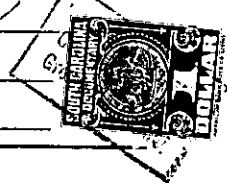
