unto Kathleen G. Kilgore, her heirs and assigns forever:

All my right, title and interest in and to that lot of land lying on the Southern side of Cyrus Court, near the City of Greenville, Greenville County, State of South Carolina, being known and designated as Lot No. 3 of plat of property of John G. Wilson, recorded in Plat Book W at Page 163 and having the metes and bounds as shown thereon.

ALSO, all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, being Lot No. 1 of a subdivision of property of S. O. Skelton, Swiss Avenue (now known as Garraux Street) as shown on a plat thereof made by R. E. Dalton Engineer, December 1921, and recorded in Plat Book F; page 51, RMC Office for Greenville County and having the metes and bounds as shown thereon.

ALSO, all that lot of land lying on the southwestern side of the property above described being more particularly described as follows:

BEGINNING at an iron pin at the joint rear corner of Lots 3 and 4, on plat of property of John G. Wilson and running thence S. 36-22 W. 42.7 feet to an iron pin on the northeast side of right of way of State Highway No. 291; thence with the northeast side of said right of way N. 40-23 W. 98.7 feet to an iron pin; thence continuing with the northeast side of said right of way N. 41-01 W. 100 feet to an iron pin; thence N. 36-22 E. 40.2 feet to an iron pin, joint rear corner of lots No. 1 and 3; thence with the rear line of Lot No. 3, S. 40-49 E. 199.8 feet to the beginning corner.
