the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

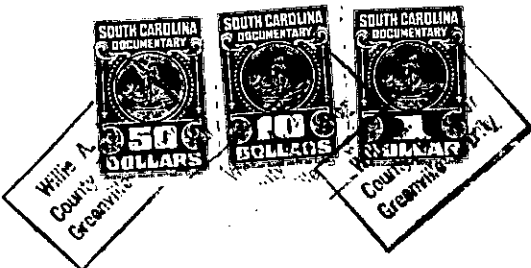
Norman McBrayer Davis, Jr. and Jane Russell Davis, their heirs and assigns forever:
