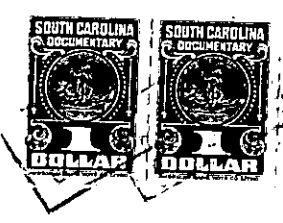
KNOW ALL MEN BY THESE PRESENTS, that I, John W. Massey,
