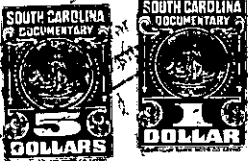

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Merrifield Court, near the City of Greenville, S.
