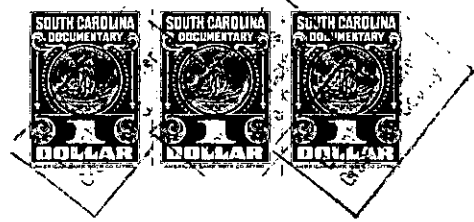
KNOW ALL MEN BY THESE PRESENTS, that I, Elizabeth Riddle Chapman, Jr.
