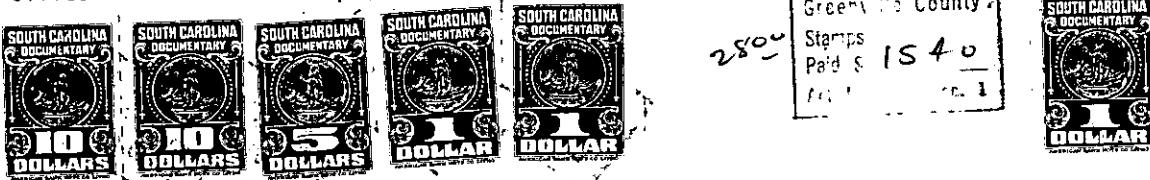

All that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, at the southwestern corner of the intersection of Prancer Avenue and Panama Avenue, being known and designated as Lot No. 300, as shown on a Plat of Pleasant Valley, recorded in the R. M. C. Office for Greenville County, in Plat Book "P", at Page 92, and having, according to said Plat, the following metes and bounds, to-wit:
