C. Hill, recorded in Plat Book II at Page 153 in the R.M.C. Office for Greenville County and also being shown on a plat of the property of Morris L. Neal, et al, dated October 19, 1959, prepared by T. C. Adams, recorded in Plat Book TT at Page 81 in the R.M.C. Office for Greenville County and having according to said latter plat the following metes and bounds, to-wit:
