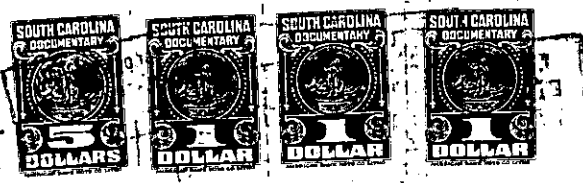
in consideration of Three Thousand Nine Hundred Ninety and no/100 (\$3,990.00) Dollars,

All that certain parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, about 8 miles North of Greer and 4 miles South of Gowansville, on the Northeast side of a 50-foot un-named road leading off S. C Highway No. 14, containing 5.7 acres, more or less, and being a portion of that property shown on a survey for G. Harold Smith, dated January 28, 1972, by W. N.
