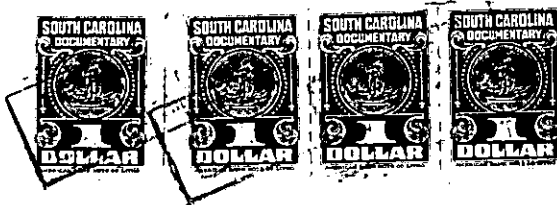
KNOW ALL MEN BY THESE PRESENTS, that **CENTRAL REALTY CORPORATION**

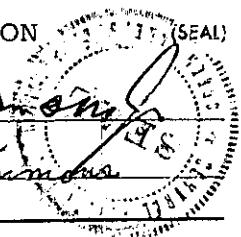
