All that lot of land in Greenville County, State of South Carolina, at the south-western corner of Third and Fourth Streets, being designated as Lot 82 on a plat of Section 6 of Judson Mills Village, recorded in Plat Book K at pages 106 and 107 in the RMC Office for Greenville County and being described as follows:

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

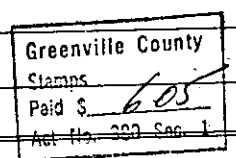
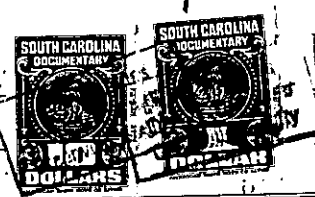
