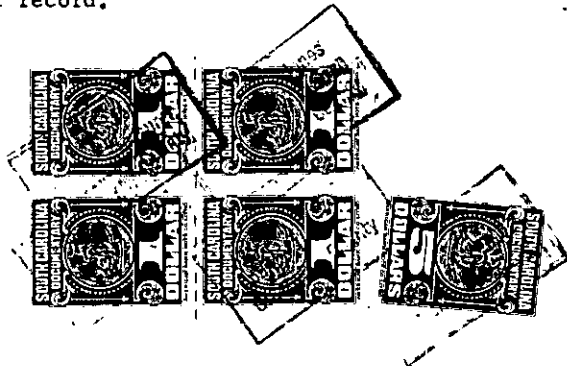
KNOW ALL MEN BY THESE PRESENTS, that Jimmy W. Peahuff -----
