the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Allan H. Cole and Sylvia G. Cole, their heirs and assigns forever,

All that piece, parcel or lot of land in the Town of Simpsonville, County of Greenville, State of South Carolina, situate, lying and being in the western corner of the intersection of Aster Drive and Coralvine Road and being known and designated as Lot No. 24 on a plat of POINSETTIA Subdivision, Section I, plat of which is recorded in the RMC Office for Greenville County in Plat Book "BBB" at Page 103, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Coralvine Road at the joint front corner of Lots 23 and 24 and running thence with the common line of said Lots N.13-06 W. 171.7 feet to an iron pin at the joint rear corner of said Lots; thence N.77-40 E. 110 feet to an iron pin on the southwestern side of Aster Drive; thence with Aster Drive S.13-06 E. 145 feet to an iron pin in the corner of the intersection of Aster Drive and Coralvine Road; thence with the curve of the intersection, the chord of which is S.31-54 W. 35.3 feet to an iron pin on Coralvine Road; thence with said Road S.76-54 W. 85 feet to the point of beginning.
