BEGINNING at an iron pin in the center of a County road, joint front corner Lots 13 and 14; and running thence S. 13-0 E. 609 feet to an iron pin; thence S. 57-15 W. 233.2 feet to an iron pin, joint rear corner Lots 14 and 15; thence along the line of Lot 15 N. 15-0 W. 683.8 feet to an iron pin in the center of said County road; thence through said County road N. 71-0 E. 150 feet to an iron pin; thence continuing through said County road N. 82-50 E. 100 feet to an iron pin, the point of beginning and containing 3.66 acres, more or less.
