All that certain piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, just south of State Highway 291 known as Pleasantburg Drive being known and designated as Lot 2 on the plat of property of Shook, Garrison and Rogers, said plat being made by C. C. Jones, Engineer, on July 30, 1954, and having, according to said plat, the following metes and bounds, to-wit:
