the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

HENRY WRIGHT AND KATHLEEN B. WRIGHT, THEIR HEIRS AND ASSIGNS FOREVER:

ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, known and designated as Lot No. 3 on a plat of View Point Acres, prepared by C. O. Riddle, Surveyor, recorded in the RMC Office for Greenville County in Plat Book 4R at page 7 and also shown on a more recent plat of Property of Henry Wright and Kathleen B. Wright prepared by Carolina Engineering and Surveying Company dated December 26, 1972 and having, according to the more recent plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeastern edge of Nancy Drive (which point is 564 feet in a northeasterly direction from the intersection of Howard Drive and Nancy Drive) at the joint front corner of Lots 2 and 3; thence with the edge of Nancy Drive, N. 59-15 E., 200 feet to an iron pin at the joint front corner of Lots 3 and 4; thence with the joint line of Lots 3 and 4, S. 30-45 E., 212.4 feet to an iron pin on the property line of L. K. Amaker; thence with the Amaker property line, S. 80-03 W., 95.2 feet to an iron pin; thence still with the Amaker line, S. 19-01 W., 94.2 feet to joint corner with property of John Williams; thence with the Williams property line, N. 53-55 W., 50 feet to an iron pin; thence continuing with the Williams line, S. 43-34 W., 20.2 feet to an iron pin at the joint rear corner of Lots 2 and 3; thence with the joint line of Lots 2 and 3, N. 30-45 W., 199.2 feet to the point of beginning.

This is a portion of that property conveyed to the grantors by deed recorded in the RMC Office for Greenville County in Deed Book 908 at page 461.

This conveyance is subject to restrictive covenants of record, set back lines, road or passageways, easements and rights of way, if any, affecting the above described property.

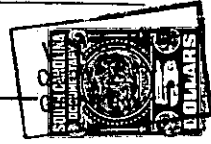
