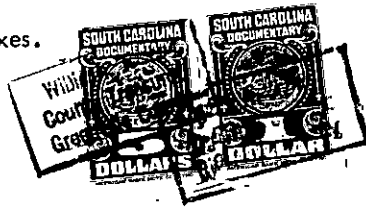
JOHN J. VEILLEUX, HIS HEIRS AND ASSIGNS, FOREVER:

BEGINNING at an iron pin on the southerly side of Cloverdale Lane, joint front corner of Lots Nos. 113 and 114, and running thence with the joint lines of said lots, S. 12-12 E. 217.8 feet to an iron pin; running thence S. 88-20 W. 85 feet to an iron pin at joint rear corner of Lots Nos. 114 and 115; thence with the joint line of said lots, N. 11-06 W. 205.1 feet to an iron pin on the southerly side of Cloverdale Lane; thence with the southerly side of said Lane, N. 79-29 E. 38.6 feet to a point; thence continuing with the southerly side of said Lane, N. 77-05 E. 41.4 feet to the point of BEGINNING.
