the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto  
OLIVE D. PHILLIPS, HER HEIRS AND ASSIGNS FOREVER:

ALL OUR RIGHT, TITLE AND INTEREST IN AND TO:  
ALL that piece, parcel or lot of land, with all buildings and improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of East Parker Road, known and designated as Lot No. 62 on plat of "Junction Heights" recorded in Plat Book C at page 106, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Eastern side of East Parker Road, at corner of Lot No. 61, and running thence with the line of said lot, N. 62-35 E., 150 feet to an iron pin in line of Lot No. 60; thence with the line of said lot, N. 37-00 W., 50 feet to an iron pin, corner of Lot No. 63; thence with the line of said lot, S. 62-35 W., 150 feet to an iron pin on East Parker Road; thence with the eastern side of East Parker Road, S. 37-00 E., 50 feet to the point of beginning.
