All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, situate and being on the east side of Country Club Drive (formerly known as Park Drive) known and designated as Lot No. 117 of Traxler Park Subdivision, as shown on a plat made by R. E. Dalton, Engineer, March, 1923, recorded in the R.M.C. Office for Greenville County, Plat Book "F", at pages 114 and 115, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Country Club Drive at the corner of Lot No. 118 and running thence along the line of Lot No. 118 N. 30-22 E. 294.5 feet to an iron pin; thence along the rear line of Lot No. 125 N. 60-28 W. 95 feet to an iron pin and corner in the rear line of Lot No. 146; thence S. 24-20 W. 286.7 feet to an iron pin on the east side of Country Club Drive; thence S. 52-36 E. 65 feet to the beginning corner.

ALSO: All that piece, parcel or lot of land situate and being on the northern side of Country Club Drive, being known and designated as Lot No. 118 of Traxler Park Subdivision and having the following metes and bounds, to-wit:

BEGINNING at a stake on the northern side of Country Club Drive to the corner of Lot No. 119 and running thence with said Drive N. 44-18 W. 65 feet to a stake; thence N. 30-22 E. 294.5 feet to a stake; thence S. 36-53 E. 105 feet to a stake; thence S. 37-27 W. 272.8 feet to the beginning corner.
