CANCELLATION OF  
ASSIGNMENT OF RENTS

WHEREAS, CHARLESTON MEDICAL CENTER, INC. and GREENVILLE MEDICAL CENTER, INC., corporations organized and existing under the Laws of the State of South Carolina, hereinafter collectively called "Assignor", did on October 7, 1969, make, execute and deliver to WALTER E. HELLER & COMPANY OF GEORGIA, hereinafter called "Heller", that certain promissory note in the principal sum of One Hundred Eighty-Three Thousand Six Hundred Twenty-Five (\$183,625.00) Dollars, and to secure the same executed that certain Real Estate Mortgage Deed recorded in Book J93, Page 404, in the office of the Register of Mesne Conveyance, Charleston County, South Carolina, and also recorded in Real Estate Mortgage Book 1138, Page 521, in the office of the Register of Mesne Conveyance for Greenville County, South Carolina, and

WHEREAS, to further secure the said note, Assignor did simultaneously therewith execute and deliver to Heller that certain Assignment of Rents which is recorded in Book J93, on Page 403, in the office of the Register of Mesne Conveyance, Charleston County, South Carolina, and also in Deed Book 877, at page 183, in the office of the Register of Mesne Conveyance for Greenville County, South Carolina, and

WHEREAS, the entire indebtedness represented by the promissory note referred to above has been repaid in full, receipt of which repayment is hereby acknowledged by Heller, and it is hereby further acknowledged by Heller that the Assignment of Rents referred to above shall be and the same is hereby cancelled and Heller now directs the Register of Mesne Conveyance in and for Greenville County and Charleston County to cancel the same of record.
