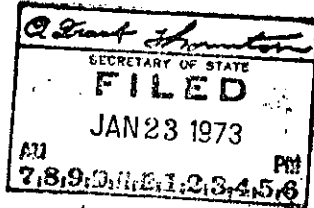

If shares are divided into two or more classes or if any class of shares is divided into series within a class, the relative rights, preferences, and limitations of the shares of each class, and of each series within a class, are as follows: **One class of common voting stock; one class of non-voting stock which will have priority in the distribution of capital upon liquidation, but shall in all other respects, save voting and priority, have the same rights as the common voting stock.**

- Total authorized capital stock One Hundred Thousand (\$100,000.00) Dollars
- It is represented that the corporation will not begin business until there has been paid into the corporation the minimum consideration for the issue of shares, which is \$1,000.00 of which at least \$500.00 is in cash.
