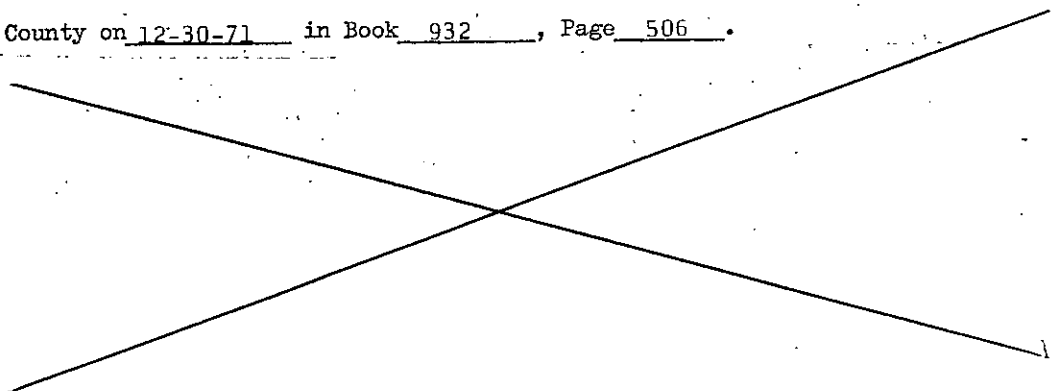

C., acting by and through the Federal Housing Commissioner, (hereinafter referred to as "Grantor"), for and in consideration of the sum of--Seventeen Thousand Five Hundred and No/100----- DOLLARS (\$ 17,500.00), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

JERRY W. BLAKLEY AND PEGGY W. BLAKLEY

(hereinafter referred to as ("Grantee(s)"), and to the heirs and assigns of said Grantee(s), the following described real estate situate in the County of GREENVILLE, State of South Carolina, to wit:

ALL that piece, parcel or lot of land with improvements thereon, situate, lying and being on the Southern side of Rockvale Drive and the Western side of Gayle Street in Gantt Township, Greenville County, South Carolina, being known and designated as Lots Nos. 14 and 15 on a Plat of ROCKVALE, Section 1, made by J. Mac Richardson, RLS, dated October, 1958, and recorded in the RMC Office for Greenville County, S.
