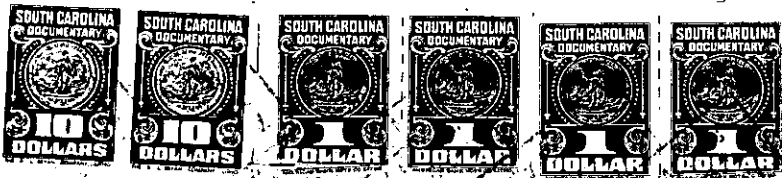

All that certain piece, parcel or lot of land situate, lying and being in State of South Carolina, County of Greenville, in Greenville Township, being known and designated as Lots 7 & 8, Block A, of subdivision known as Jefferson Heights as shown on plat thereof being recorded in the RMC Office for Greenville County in plat Book C at pages 34 & 35, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on eastern side of First Avenue (now known as Rebecca Avenue), joint front corner of Lots 8 & 9, and running thence with the joint line of said lots N. 81-40 E. 87.5 feet to an iron pin at rear corner of Lot # 33; thence with the rear line of Lots 33 & 32, N. 0-30 E. 51 feet to an iron pin at joint rear corner of Lots 6 & 7; thence with the joint line of said lots S. 81-40 W. 87.5 feet to an iron pin on the eastern side of First Avenue; thence with First Avenue S. 0-30 W. 51 feet to the beginning corner.
