

KNOW ALL MEN BY THESE PRESENTS, that I, Gerald Keith Carter, GREENVILLE, CO. S. C.

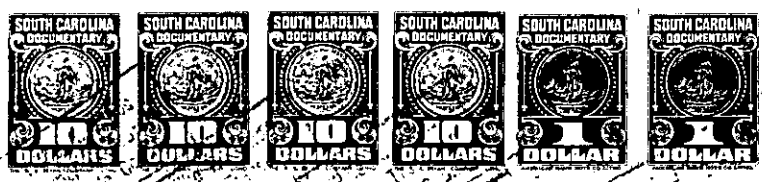
in consideration of Twenty Thousand Nine Hundred Fifty and No/100 (\$20,950.00)-----Dollars,
