the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto FOUNTAIN INN BUILDERS, INC., its successors and assigns, forever:

ALL that piece, parcel or lot of land, lying, being and situate in the County of Greenville, State of South Carolina, near the Town of Fountain Inn, being shown and designated as Lot 9 on a plat entitled "Survey for Fountain Inn Builders, Inc." prepared by Joe E. Mitchell, R.L.S., dated October 12, 1972, revised October 26, 1972, and revised January 12, 1973, and being more particularly described in accordance with said revised plat of January 12, 1973, to-wit:

BEGINNING at an iron pin in the edge of Hellams Street, and running thence along the joint property line of Lot 8 S. 67-54 E. 305.5 feet to an iron pin at the joint rear corner of Lots 8 and 9; running thence along the joint property line of Woodland Heights Subdivision S. 8-00 E. 46.1 feet to an iron pin; thence continuing along joint property line of Woodland Heights S. 27-18 W. 36.2 feet to the joint rear corner of Lots 9 and 10; running thence along the joint property line of Lot 10 N. 69-51 W. 325.4 feet to a point in the edge of Hellams Street; thence along the edge of Hellams Street N. 22-01 E. 87.0 feet to the point of beginning.
