DOUGLAS W. DIXON and ELAINE M. DIXON, their heirs and assigns forever:

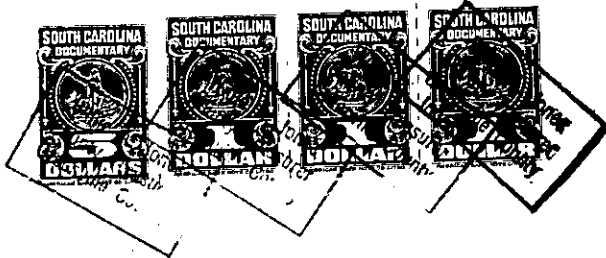

BEGINNING at an iron pin at the joint front corner of Lots 24 and 25 and running thence with the line of said lots, South 85-37 East 169.2 feet to the joint rear corner of said lot; thence South 4-33 West 140 feet more or less to the joint rear corner of Lots 25 and 26; thence with the line of said lots, North 81-25 West 169 feet to an iron pin on Holly Road; thence with said Road, North 6-26 East 15 feet; thence continuing North 4-23 East 110 feet to the beginning corner.
