the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto B-T-M Corporation, its successors and assigns, forever:

All those pieces, parcels of lots of land being shown and designated as Lots 1-13 according to plat of property of C. S. Willingham dated March 10, 1967 made by Carolina Engineering Company. According to said plat the property is more fully described inclusively as follows:
