BEGINNING at an iron pin on the Southeastern side of Gallivan Street at the joint front corner of Lots Nos. 6 & 7 and running thence with the line of Lot No. 7, N. 24-30 E. 169 feet to a point in branch at the joint rear corner of Lots Nos. 6 and 7; thence with the line of said branch, the traverse line of which is S. 72-0 E. 65.3 feet to a point in said branch at the joint rear corner of Lots Nos. 6 and 5; thence with the line of Lot No. 5, S. 24-30 W. 163 feet to an iron pin on the Southeastern side of Gallivan Street; thence with the Southeastern side of Gallivan Street, N. 65-30 W. 65 feet to the point of beginning.
