ALL that certain piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, on the branch waters of Gap Creek, and having the following metes and bounds, to-wit:

BEGINNING at a rock corner on Spring Branch, adjoining the property of Ella Plumley; thence in a westerly direction to Gap Creek; thence in a northerly direction along Gap Creek to Old Indian Mountain Road; thence in a northeasterly direction on Old Indian Mountain Road to an iron pin on Highway 118; thence in an easterly direction along Highway 118 to an iron pin on Highway 118; thence in a southeasterly direction to an iron pin in Spring Branch; thence southwesterly along said Spring Branch to the beginning corner, containing two and one half (2 & 1/2) acres more or less.
