KNOW ALL MEN BY THESE PRESENTS, that I, Charles J. Spillane

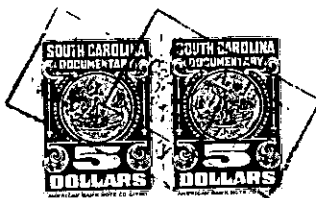
in consideration of Four Thousand Seven Hundred Seventy Eight and No/100 ----- (\$4,778.00)----- Dollars,
