All that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots 25, 26, 27 and 28 on plat of Property of Augusta Park, Property of M. C. Westervelt, Trustee, Addition to Greenville, South Carolina, recorded in Plat Book F at Page 23 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeastern side of Waccamaw Avenue, joint front corner of Lots 24 and 25, running thence with Lot 24, S. 71-35 E. 166.36 feet to an iron pin; thence S. 21-35 W. 200 feet to an iron pin, joint rear corner Lots 28 and 29; thence with the line of Lot 29, N. 71-35 W. 166.36 feet to an iron pin on Waccamaw Avenue; thence with said Waccamaw Avenue, N. 21-35 E. 200 feet to the point of beginning.
