GRANTEE to pay 1973 taxes.



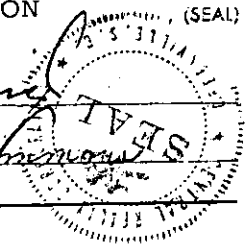
