All that certain piece, parcel, or lot of land in the City of Greenville, County of Greenville, State of South Carolina, known and designated as the major part of Lot No. 18, on plat of Property of Mountain City Land & Improvement Company, recorded in the RMC Office for Greenville County, S. C., in Deed Book "VV", at Pages 542-543, and also being shown on more recent plat entitled "Survey for Alvin Trammell", prepared by Carolina Engineering & Surveying Company, on 21 December 1970, and having, according to said more recent plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northerly side of Stone Avenue, said iron pin being 272.5 feet east of the intersection of Stone Avenue and Elizabeth Street, and being the joint front corner of Lots Nos. 17 and 18, and running thence along the joint lines of said lots, N. 16-33 E. 207.6 feet to an iron pin; running thence S. 73-00 E. 50 feet to an iron pin; running thence S. 16-33 W. 207.6 feet to an iron pin on the northerly side of Stone Avenue; running thence along the northerly side of Stone Avenue, N. 73-00 W. 50 feet to the point of BEGINNING.
