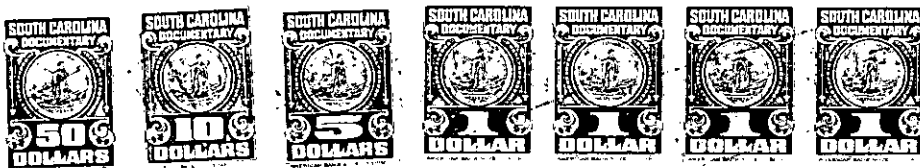
in consideration of **Thirty-Four Thousand Five Hundred and no/100 (\$34,500.00)** ----- Dollars,
