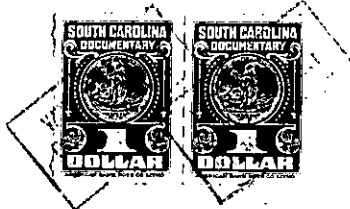
JAMES LOUIS FARMER, His Heirs and Assigns:
