the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Milton Minyard, his heirs and assigns forever

All those lots of land situate on the northeastern side of Winston Avenue, in the County of Greenville, State of South Carolina, being shown as lots 95, 96, and 97 on a plat of Wynette Estates dated July 24, 1953, prepared by Pickell and Pickell Engineers, recorded in Plat Book EE at Page 37 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Winston Avenue at the joint front corner of lots 94 and 95 and running thence with lot 94-N. 55-10 E. 207 feet to an iron pin at the joint rear corner of lots 94 and 95, said iron pin being on the southwestern boundary of a gas easement; thence with said gas easement S. 26-02 E. 172 feet to an iron pin on the western side of Wellimon Drive; thence with said Drive S. 18-30 W. 135.1 feet to an iron pin; thence still with said Drive S. 40-13 W. 90 feet to an iron pin at the intersection of Wellimon Drive and Winston Avenue; thence with said Avenue N. 31-50 W. 285 feet to the point of beginning.

This property is conveyed subject to restrictions recorded in Deed Book 495 at Page 523 and is also conveyed subject to all other recorded easements and restrictions affecting said property.
