All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the northeasterly side of Continental Drive, near the City of Greenville, S. C., being known and designated as Lot No. 79 on plat entitled "Final Plat Revised Map # 1, Foxcroft Section II" as recorded in the RMC Office for Greenville County, S.
