grant, bargain, sell and release unto the said Hazel Neves Thompson and her Heirs and

Assigns forever:

All that certain parcel or tract of land containing Thirty-six
and 2/10 (36.2) Acres, more or less, situated on the East side of
the Tigerville Road, near Locust Hill Baptist Church, in Oneal
Township, Greenville County, State of South Carolina, and having
courses and distances according to survey and plat of the Property
