Beginning at an iron pin on the south side of Palmetto Avenue the joint front corner of lots # 3 & 4; thence with the joint line of said lots S. 10-15 W. 125 feet to an iron pin on the north side of a 15 feet alley; thence with the north side of said alley N. 79-45 W. 50 feet to an iron pin corner of lot #5; thence with the line of said lot N. 10-15 E 125 feet to an iron pin on the south side of Palmetto Avenue; thence with the south side of said street N. 79-45 W. 50 feet to the beginning corner.
