KNOW ALL MEN BY THESE PRESENTS, that we, E. Franklin Gault, J. A. Gault, Edna Elizabeth Gault, Elna G. Sims and Hassie G. Sheriff,

In consideration of Seven Thousand Seven Hundred & 90/100 (\$7,700.90) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Atlantic Land and Improvement Company, its successors and assigns:

ALL that certain piece, parcel or tract of land, with improvements thereon, lying, being and situated in Fairview Township, County of Greenville, State of South Carolina, containing a total of 4.8 acres designated as Tract #2 in accord with plat made for Seaboard Coastline Railroad Co. dated February 20, 1973 by Piedmont Engineers, Architects & Planners. Said plat further reflects 1.3 acres presently consumed in S. C. Hwy. right-of-way and present railroad right-of-way, resulting in a net conveyance of 3.5 acres. Said tract is more particularly described, to-wit:

BEGINNING at an iron pin on the edge of S. C. Hwy. right-of-way and within the former railroad right-of-way, being joint corner with property of J. J. and Annie Belle Brown, and running thence along said highway right-of-way S. 47-56 E. 100 feet to iron pin; S. 45-47 E. 100 feet to iron pin; S. 43-53 E. 100 feet to iron pin; S. 42-22 E. 72 feet to iron pin; thence N. 46-59 E. 7.5 feet to iron pin; thence S. 40-27 E. 78.05 feet to iron pin; S. 38-06 E. 342.05 feet to iron pin, being the Southeastern edge of S. C. Hwy. right-of-way as pertains to this property; thence turning and running S. 85-49 W. 352.7 feet to iron pin; thence S. 41-37 E. 650.8 feet to iron pin; thence N. 63-47 E. 282.1 feet to iron pin, being the point of beginning. This being a portion of the property conveyed to S. C. Gault by deed recorded in the R.M.C. Office for Greenville County in Deed Book 126, Page 502, and the grantors herein are the children of S. C.
