This property is conveyed subject to all easements and restrictions and rights-of-way of record or on the ground and zoning ordinances affecting said property, if any.

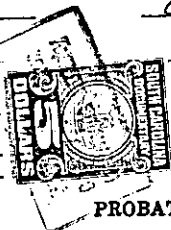
