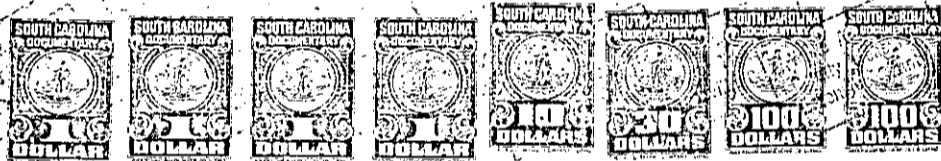

C. E. RUNION, his heirs and assigns forever:

According to a plat of property of C. E. Runion prepared by John A. Simmons, Registered Land Surveyor on January 22, 1973, and according to said survey containing 48.8 acres on Gibbs Shoals Road.
