In consideration of Five Thousand Six Hundred Seventy-Nine & No/100(\$5,679.00) Dollars, and assumption of mortgage described below; the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Mildred W. Harvey, her heirs and assigns:

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being located at the intersection of Melody Drive and Sharon Drive, and being known and designated as the greater part of Lot No. 85 as shown on plat of Extension of Sharon Park, prepared by C. C. Jones, dated December 1962, which plat is of record in the RMC Office for Greenville County, S. C., in Plat Book CCC, Page 71, and being more specifically shown according to plat prepared by R. K. Campbell dated October 15, 1965, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Sharon Drive, joint front corner of Lots Nos. 85 and 86; running thence S. 27 E. 137.2 feet to an iron pin; thence on a new line through Lot No. 85 S. 78-53 W. 124.2 feet to an iron pin on the eastern side of Melody Drive; running thence along Melody Drive N. 14 W. 64 feet to an iron pin; running thence 20.7 feet to an iron pin; running thence with the curve of the intersection, the chord of which is N. 18 E. 28.3 feet to an iron pin on Sharon Drive; running thence along Sharon Drive N. 63-03 E. 85 feet to the beginning corner.

This conveyance is made subject to all restrictions, easements and rights-of-way which may affect the property hereinabove described.

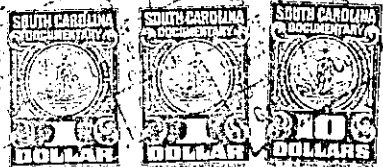
