- 3. Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due the undersigned, as rental, or otherwise, and howsoever for or on account of that certain real property situated in the County

<u>Greenville</u> . Scate of South Carolina, described as follows: BEGINNING at an iron pin on the W.side of the 20 ft.St., as laid out on plat of Carl R. Vest made by W.P. Morrow in March, 1946 which point is 211.6 ft.N/W of McElhanev Rd. & is the rear corner of Lot 2 on said plat & running thence along the Eastside of a St. as laid out on the grounds across lot 1, N.18-00 W.229 ft. more or less to an iron pin in the rear line of lot 9; thence along the rear line of Lot 9 & Lot 8 & crossing said proposed St., N.62-00 E.110 ft. to an iron pin at the rear corner of lots 7 & 8; thence across lot 3, S.13-00 E.200 ft.to an iron pin at the rear corner of Lot 2 & property now or formerly belonging to Roe; thence along the rear line of Lot 2, S.10-00 W.105 ft. to the beginning corner. - 4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
