Grantee is to pay 1973 property taxes. -278-525.2-1-37.

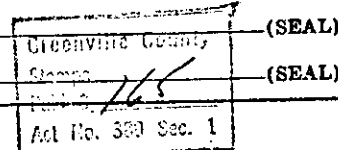
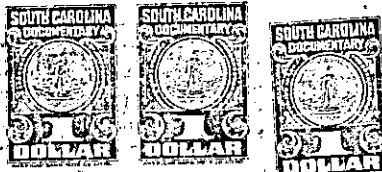
